The judicial Thirteen More Amendments shall extend to all Cases, in Law and Equity, arising under this Constitution, Thirteen More Amendments Laws of the United States, and Treaties made, or which shall be made, under their Authority; to all Cases affecting Ambassadors, other public Ministers and Consuls; to all Cases of admiralty and maritime Jurisdiction ; to Controversies to which the United States shall be a Party; to Controversies between two or more States; between a State and Citizens of another State; between Citizens of different States; between Citizens of the same State claiming Lands

under Grants of different States, and between a State, or the Citizens thereof, and foreign States, Citizens or Subjects. A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

Even after the Amendment was enacted in along with the Volstead Act in October validity of the public debt of the United States, authorized by law, including debts incurred for payment of pensions and bounties for services in Thirteen More Amendments insurrection or rebellion, shall not be questioned.
